Sir/Madam,

With reference to your online application dated 14.11.2011 on the subject cited above, I am directed to convey the sanction for <u>Composite Provisional Affiliation for Secondary School</u> <u>Examination and Senior School Certificate Examination</u> of the Board for a period of three years w.e.f. 01.04.2013 to 31.03.2016. The following subjects have been sanctioned to be introduced at Senior Secondary classes :-

- (a) Languages:- English Core/Elective, Hindi Core/Elective, Manipuri, Mizo
- (b) **Elective Subjects:** Physics, Chemistry, Biology, Mathematics, Computer Science, History, Geography, Political Science, Economics, Psychology, Sociology, Home Science, Accountancy, Business Studies.

The above sanction is subject to fulfillment of following conditions:-

- 1. "School will follow the syllabus on the basis of curriculum prescribed by NCERT for the middle classes".
- 2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
- 3. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
- 4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
- 5. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and Senior School Certificate Examination and changes made therein from time to time."
- 6. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
- It will abide itself by the Affiliation Bye.Laws of the Board and other rules and regulations prescribed by the Board from time to time.

8. It is case of switch over from State Board; the school is required to withdraw its affiliation from such Board as dual affiliation is not permissible. Also State Board classes IX and XI will not be continued w.e.f. 01.04.2013 However, for the Class X and XII Examination to be held in the year 2014, the school will sponsor its students for State Board only.

9. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

- 10. The School will not sponsor candidates for Board's examination of any other School/Branch,
- 11. The school shall sponsor regularly its bonafide and eligible students in Board's class X and XII Examination from the year mentioned above without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates. Failure to do so will lead to suo moto withdrawal of the affiliation of the school for secondary Examination granted by the Board.
- 12. The school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
- 13. Service conditions, pay and allowances and other benefits to the employees of the school shall be at least at par with that of corresponding categories of employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
- 14. Service agreement be executed with the staff as per norms generally accepted by the State
- 15. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and
- furniture at its disposal for holding its examinations free of charges if required. 16. The school will spare sufficient teachers, for invigilation purpose at the examinations of the
- 17. The school will spare its teachers for evaluation of answer-books for the Board's
- 18. The school will provide Laboratories, Library and other facilities as per norms of the Board. 19. The school will abide itself by the conditions of affiliation already prescribed by the State
